IMPLEMENTATION OF NEW ACCREDITATION POLICIES

1 INTRODUCTION

New Accreditation Policies (AP) were established and harmonised based on the existing SAMM, MIBAS, MyPTP and ACB policies which are applicable to all accreditation schemes offered by the Department of Standards Malaysia (JSM). The requirements in these AP series (as in **Clause 3.1**) are also aligned with the relevant standards, international requirements and guidelines.

2 OBJECTIVE

This circular aims to inform conformity assessment bodies (CABs) on the implementation of new AP series by all applicants and accredited CABs.

3 IMPLEMENTATION OF AP SERIES

3.1 All applicants and accredited CABs shall comply with the relevant requirements stipulated in the AP series from the effective date as follows:
