IMPROVING SUPPLY CHAIN OF HALAL INDUSTRY WITH HALAL PACKAGING STANDARD

PUTRAJAYA, 28 August 2019 – Department of Standards Malaysia, Malaysian Plastics Manufacturers Association (MPMA) and Department of Islamic Development Malaysia (JAKIM) jointly organised the Seminar on "Halal Packaging"- What you need to know, today. This seminar aimed to provide useful and valuable knowledge to the industry to improve their Halal business operations and stay ahead of the competition in the growing halal market.

The Malaysian Standard, MS 2565-Halal Packaging: General Guideline was developed by Standards Malaysia, and it describes the general guidelines in the manufacturing and handling of halal packaging and serve as a basic requirement for halal packaging for halal products in Malaysia. The seminar was officiated by Director General of Standards Malaysia, Datuk Fadilah Baharin, in the presence of the Secretary-General of MPMA, Mr. Eddie Fong.

"The global halal market size is expected to reach US\$9.71 trillion by 2025, with countries such as Malaysia, set to lead the pack over the coming years. To capture the whole demand of global halal industry and accelerate the growth of Malaysian halal industry, we have developed 14 Halal Standards, which are not exclusively for food, but have been extended to other categories including pharmaceuticals, healthcare, cosmetics, and other consumer goods including packaging," said Fadilah.

Meanwhile, Eddie Fong said major growth drivers for the Halal packaging market include the growing Muslim population across the world, the increased marketability of products due to Halal certification and the improved awareness about Halal certified products and services. The Halal market is not just confined to the Middle East and some of the South-East Asia countries like Malaysia and Indonesia, but also covers many countries, including China, countries in Asia, Europe as well as the South and North America.

The plastics industry can provide a wide range of packaging solutions to the Halal market, including barrier films, laminated films, containers, bottles and closures, trays, vacuum packs, etc. Plastics packaging, therefore, is an important enabler within the entire supply chain of the Halal industry.

Eddie Fong also mentioned many plastics companies are already supplying or planning to supply plastic packaging materials to the Halal market. However, most of the members about 90% are SMEs with limited capital and human resources. They are also facing various challenges when they are exploring the Halal packaging market. In this regard, MPMA truly hope that the relevant Government agencies, including JAKIM, Standards Malaysia, MATRADE and Malaysian Technology Development Corporation (MTDC) could support their members by providing the necessary support and facilitation.
