## **1. INTRODUCTION**

- 1.1 This document details Department of Standards Malaysia's (JSM) policy for the purpose of determining, granting, extending, renewal, reducing, maintaining, reinstating, suspending and withdrawal of scope of accreditation as well as witnessing activities based on the scope of accreditation.
- 1.2 The policy is also applicable for the management of JSM accredited scopes by certification bodies for the purpose of determining certification, as well as to determine the resources and competencies to be applied to the audit of an organisation.

## **2. SCOPE**

- 2.1 The policy applies to all certification bodies applying for JSM accreditation and those who are already accredited by JSM under the Scheme for the Accreditation of Certification Bodies (ACB Scheme).

#### 4. DEFINITIONS

- 4.1 For the purpose of this document, in addition to the definitions in the relevant ISO standards and IAF documents, the following definitions apply:
  - 4.1.1 **ACB Accreditation Criteria**  
ACB Accreditation Criteria is defined as criteria documents developed by JSM for specific accreditation programmes under the ACB Scheme.
  - 4.1.2 **Dormant Scope**  
Dormant scope /area is defined as the scope /area where the certification body has qualified auditors / technical experts but does not have any certified organisation.

#### 5. POLICY ON SCOPE OF ACCREDITATION

##### 5.1 Granting of Scope of Accreditation

- 5.1.1 Unless otherwise specified, the scope of accreditation of a certification body is expressed in terms of one or more elements from industrial sectors or product categories, known as the "scope of accreditation" as in **ANNEX 1**. JSM has adopted the statistical nomenclature for economic activities (NACE Rev.2) 2006, published by the Commission of European Communities (official Journal 393/1, 30.12.2006) as the basis for defining the scope of accreditation and certification.
- 5.1.2 Accreditation scope under JSM accreditation system is to be defined based on the general scope number. There is no limitation placed on the sub-divisions of the broad description given in Annex 1 that a certification body may seek accreditation for. However, for certification bodies operating in a limited area, such as industry sector-specific certification schemes, the accreditation scope would normally be limited to one broad description as described in **ANNEX 1**. In some cases, it may be appropriate for the certification body to define its scope at the division, group or

class level. In determining the most appropriate scope to apply for, certification bodies may consult JSM prior to applying for accreditation.

- 5.1.3 The table listing accreditation programmes whereby the scope of accreditation are specified are as per Annex 2
- 5.1.4 Certification bodies shall document and be able to demonstrate competence to the accreditation programme for JSM to grant accreditation to the applied scope.

## **5.2 Dormant scope(s)**

- 5.2.1 JSM may grant accreditation for dormant scope(s).
- 5.2.2 If the certification body intends to certify in scopes identified as dormant scopes especially identified as critical code(s) the certification body shall submit documentation of its competency as well as allow JSM to perform a witnessing assessment prior to activation of a dormant scope.
- 5.2.2 However, if after an accreditation cycle (Five (5) years), the Certification Body fails to activate the scope, JSM reserves the right to reduce the scope of accreditation.
- 5.2.3 If the scope is maintained, the dormant scope is maintained for a period not exceeding two (2) accreditation cycles (i.e. ten (10) years) if there are no clients certified during the aforementioned period.

## **5.3 Extension of scope(s)**

- 5.3.1 If a certification body intends to extend its scope of accreditation, the certification body shall submit documentation of its competency as well as allow JSM to perform a witness assessment for that particular scope to be considered for granting of extension of scope.
- 5.3.2 For Product Certification and Certification of Persons, in addition to the mentioned in 5.3.1, the certification body shall conduct a standards review on the criteria documents to be used for extension of scope.
- 5.3.3 If extension of scope is granted for a dormant scope, the activation of a dormant scope shall follow Clause 5.2 of this document.

## **5.4 Scope of accreditation to a sub-element of a general scope:**

- 5.4.1 A certification body can request for a scope to be specified to a specific NACE division, group or class.

- 5.4.2 JSM reserves the rights to limit the scope of accreditation to a specific NACE division, group or class.

## **5.5 Certification Scope**

- 5.5.1 Whereby the standards or a scheme requirements specify the competency for a scope concerned, the standards or scheme requirements shall prevail. Whereby the standards or a scheme requirements do not specify the competency for a scope concerned, the certification bodies shall ensure that it has at least one member of an audit team that has experience in the scope concerned. Experience in the scope concerned shall be judged using the following guidance:
- (a) identification of scope of industrial or service sector in which certification is offered; and
  - (b) relevant experience and competence to be within the defined area / sector.
- 5.5.2 The scope of certification shall be defined to be precise and clear so that clients' interested parties and the organizations themselves will know accurately and unambiguously the certification scope. In some cases, additional descriptors may be necessary to define the scope of certification more closely. In defining the scope of certification, some attempt should be made to limit the additional descriptors to common terms, so that a uniform description may be applied to all suppliers from that specific industry.
- 5.5.3 For management systems certification, JSM only allows certification bodies to issue JSM accredited certificates for the core business of the organisation being certified.

## **6.0 POLICY ON WITNESSING ACTIVITIES OF CERTIFICATION BODIES**

- 6.1 The scope and witnessing activities shall directly refer to standards or documents whereby they have already been defined for a specific accreditation programmes. Annex 2 provides a list of standards/document for programmes offered under JSM accreditation.
- 6.2 General arrangements for witnessing assessments are as follows:
- 6.2.1 Prior to witnessing assessment:
- a. In January of each year, JSM will distribute the witnessing assessment programme to each CB requesting for the specific code/category/technical area to be witnessed based on each programme accredited. CB shall follow-up with accreditation officer-in-charge if not received witnessing assessment programme in January of each year.

- b. The CB shall email the accreditation officer-in-charge copying [acb@ism.gov.my](mailto:acb@ism.gov.my) with the proposal of client's to be witnessed for the scopes requested by JSM within two (2) weeks after the witnessing assessment programme is distributed. The CB may counter propose with a different scope with valid justification subject to the approval of the ACB Scheme Manager.

#### 6.2.2 Arrangement of witnessing assessments:

- a. The CB shall at least one (1) week prior to the witnessing assessment, provide the following documents to JSM:
  - i. Audit plan;
  - ii. Auditor competency for the code/category/technical area to be witnessed;
  - iii. Manday calculation; and
  - iv. Previous audit report (if available).
- b. Failure to submit the documents within the stipulated time may result in the cancellation of the witnessing assessment by JSM. All incidental costs arising from the negligence of the CB in arranging the witnessing assessment, shall be borne by the CB.

#### 6.3 Arrangements for applicants

##### 6.3.1 For Management Systems and Product Certification:

- a. The CB shall be able to demonstrate that it has clients or has auditors who are competent to certify to the scope applied; and
- b. JSM shall witness at least ONE (1) compliance or ONE (1) recertification or TWO (2) surveillance audits.

##### 6.3.2 For Certification of Persons:

- a. The CB shall be able to demonstrate that it has clients or examiners who are competent to certify to the scope applied; and
- b. JSM shall witness examiners conducting examination on persons based on the certification scheme applied.

#### 6.4 Arrangements for maintenance of accreditation

##### 6.4.1 For Management Systems

Witnessing audits shall be carried out as per the table below:

\*Note: For every subsequent addition of 1,000 certificates, an additional witness audit shall be added.

##### 6.4.2 Product Certification and Certification of Persons:

Witnessing audits shall be carried out per scheme as per the table below:

#### 6.5 Arrangements for extension of scope

Where there are no standards or documents governing the arrangements for extension of scope, the following shall apply:

3. WA – Witnessing Assessment
